

RESOLUTION No. 200915

Adopted on OCT 1 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of IRVIN J. KAHN, executed in favor of The City of San Diego, bearing date July 16, 1970, conveying to said City an easement and right of way for street purposes through, over and across portions of Quarter Sections 77 and 79, Rancho de la Nacion, according to Map thereof No. 166, filed in the office of the County Recorder of San Diego County, May 11, 1869, as more particularly described in said deed, as certified by the Property Director, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named PARADISE VALLEY ROAD.

That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Department for recording and further disposition.
