

RESOLUTION No. 200916

Adopted on OCT 1 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of GEORGE A. BJORKLUND and DAVID B. HAIGHT, Trustees, and their successor Trustees, of the George A. and Alice N. Bjorklund Memorial Trust Fund With Brigham Young University, as to an undivided 80 per cent interest; and BRIGHAM YOUNG UNIVERSITY, as to an undivided 20 per cent interest, executed in favor of The City of San Diego, bearing date June 3, 1970, conveying to said City an easement and right of way for sewer purposes, through, along and across portions of the East Half of the West Half of the Northeast Quarter; and of the Northeast Quarter of the Northeast Quarter of Section 15, Township 14 South, Range 3 West, San Bernardino Meridian according to the United States Government Survey thereof, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director be, and the same is hereby approved.

That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Department for recording and further disposition.
