

RESOLUTION No. 200923


Adopted on OCT 1 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of HOFER & SONS, INC., a California corporation, executed in favor of The City of San Diego, bearing date August 17, 1970, conveying to said City an easement and right-of-way for street purposes through, over and across a portion of the Northeast Quarter of the Northwest Quarter of the Southeast Quarter of Section 28, Township 18 South, Range 2 West, San Bernardino Base and Meridian, according to United States Government Survey approved February 25, 1870 and a portion of Lot 9 of Nestor, according to Licensed Survey Map No. 90, filed in the Office of the County Recorder of San Diego County, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named CORONADO AVENUE.

That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Department for recording and further disposition.


