That the acceptance by the City Manager of that deed of HOFER & SONS, INC., a California corporation, executed in favor of The City of San Diego, bearing date August 17, 1970, conveying to said City an easement and right-of-way for drainage purposes, through, along and across a portion of Lot 9 of Nestor, according to Licensed Survey Map No. 90, filed in the Office of the County Recorder of San Diego County, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director be, and the same is hereby approved.
