

RESOLUTION NO. 200934 OCT 6 1970

APPROVING MAP OF MIRA MESA VERDE UNIT NO. 12
SUBDIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC
THE PUBLIC STREETS AND PORTION OF PUBLIC STREET
DEDICATED ON SAID MAP AND ACCEPTING ON BEHALF OF
THE CITY OF SAN DIEGO CERTAIN ABUTTERS' RIGHTS
OF ACCESS AS GRANTED ON THIS MAP WITHIN THIS
SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by WILLIAM J. CLARKE, Licensed Land Surveyor, and entitled,
"MIRA MESA VERDE UNIT NO. 12 Being a subdivision of a
portion of Section 31, Township 14 South, Range 2 West, San
Bernardino Meridian, in the City of San Diego, County of
San Diego, State of California, according to the official
Plat thereof.", is made in the manner and form prescribed
by law and conforms to the surrounding surveys; that said
map and the subdivision of land shown thereon is hereby
approved and accepted; and said Council hereby accepts on
behalf of the public, the public streets and portion of
public street, to wit: Flanders Drive, Hebrides Drive,
Friant Street, Dunholme Street, Woodlawn Drive, Isleworth
Avenue, Stanfield Circle, Bedfont Circle, Greenford Drive,
Londonderry Avenue, Baywood Lane, Baywood Avenue, Brookhurst
Lane, Brookhurst Avenue, Glenellen Avenue, Glenellen Lane,
Westchester Avenue and portion of Gold Coast Drive, for
public purposes and said streets and portion of street are
hereby declared to be public streets and portion of public
street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council accepts on
behalf of The City of San Diego, a municipal corporation,

any and all abutters' rights of access in and to Flanders Drive, adjacent and contiguous to Lots 1380, 1381, 1402, 1403, 1423, 1424, 1444, 1445, 1464, 1465, 1484, 1485, 1504, 1505, 1524, 1525 and 1535; any and all abutters' rights of access in and to Dunholme Street adjacent and contiguous to Lots 1435, 1454, 1455, 1474, 1475, 1494, 1495, 1514, 1515, 1534, 1544, 1545, and 1634; any and all abutters' rights of access in and to Woodlawn Drive, adjacent and contiguous to Lots 1565, 1566, 1581, 1582, 1597, 1598, 1613 and 1614; any and all abutters' rights of access in and to Westonhill Drive, adjacent and contiguous to Lots 1325, 1342, 1343, 1360 and 1361; any and all abutters' rights of access in and to Isleworth Avenue, adjacent and contiguous to Lots 1333, 1334, 1351 and 1352; any and all abutters' rights of access in and to Londonderry Avenue, adjacent and contiguous to Lots 1635, and 1670; any and all abutters' rights of access in and to Gold Coast Drive, adjacent and contiguous to Lots 1557, 1558, 1573, 1574, 1589, 1590, 1605, 1606, 1621 and 1622; any and all abutters' rights of access in and to Westchester Avenue, adjacent and contiguous to Lots 1652 and 1653, all as granted and shown on said map.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portion of public street are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
