WHEREAS, heretofore, by deed dated May 27, 1920, and recorded March 3, 1921, in Book 847, Page 50 of Deeds, and deed dated July 3, 1920, and recorded March 3, 1921, in Book 847, Page 46 of Deeds, all in the office of the San Diego County Recorder, The City of San Diego acquired easements for water purposes affecting portions of Lots 44 through 51, Block 9 of Del Mar Terrace; and

WHEREAS, the need for said water easements has been eliminated by reason of replacement water mains and said easements have not been used for such purposes for a period of more than five (5) years; and

WHEREAS, the City has no present or prospective use for said easements and the City Manager has recommended that the City vacate its interest therein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That, pursuant to Section 50443 of the Government Code of the State of California, the water easements more particularly described hereinafter are hereby vacated:

PARCEL 1:

That certain easement for water purposes affecting portions of Lots 44 and 45, Block 9 of Del Mar Terrace, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 1527, filed in the office of the San Diego County Recorder, as described in deed to The City of San Diego from Alvah Bailey, dated May 27, 1920, filed in the office of the City Clerk of San Diego as Document No. 133956, and recorded on March 3, 1921 in Book 847, Page 50 of Deeds, in the office of said San Diego County Recorder.

PARCEL 2:

That certain easement for water purposes affecting portions of Lots 46 through 51, Block 9 of said Del Mar Terrace, as described in deed to The City of San Diego from J. D. Miller Realty Company, dated July 3, 1920, filed in the office of the City Clerk of San Diego as Document No. 133957, and recorded on March 3, 1921 in Book 847, Page 46 of Deeds, in the office of said San Diego County Recorder.

That from and after the date of this order of vacation, title to the land previously subject to said water easements shall revert to the owners of the land free from the rights of the public.

BE IT FURTHER RESOLVED, that the City Clerk of said City be, and he is hereby authorized and directed to cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder of said County of San Diego.
