

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That an easement for the purpose of a right-of-way for
a public sewer and appurtenances thereto, through, over, under,
along and across the hereinafter described property be, and the
same is hereby set aside for such public purposes:

That portion of Pueblo Lot 1279 of the Pueblo
Lands of San Diego, in the City of San Diego,
County of San Diego, State of California,
according to map thereof made by James Pascoe
in 1870, a copy of which said map was filed
in the Office of the County Recorder of said
county, and known as Miscellaneous Map No. 36,
described as follows:

Beginning at the Northwest corner of Pueblo
Lot 1290 of said Pueblo Lands; thence along
the Northerly line thereof, North 75° 56' 08"
East, a distance of 401.91 feet to the TRUE
POINT OF BEGINNING; thence North 77° 37' 38"
West, a distance of 121.72 feet; thence
North 68° 11' 52" East, a distance of 9.23
feet; thence North 02° 23' 27" East, a dis-
tance of 9.97 feet; thence South 77° 37' 38"
East, a distance of 145.98 feet to said
Northerly line of Pueblo Lot 1290; thence
along said line, South 75° 56' 08" West, a
distance of 33.70 feet to the TRUE POINT OF
BEGINNING.
