

RESOLUTION No. 200955

Adopted on OCT 6 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of LEON R. HUBBARD, JR. and ELIZABETH M. HUBBARD, executed in favor of The City of San Diego, bearing date August 6, 1969, conveying to said City an easement and right-of-way for street purposes through, over and across a portion of that certain tract of land designated as "Hoffman" on Encanto, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 749, filed in the office of the County Recorder of San Diego County May 6, 1893, being a portion of the Northerly 5 acres of said "Hoffman" Tract as described in deed to Leon R. Hubbard, et al, recorded December 31, 1963 as File No. 232229, as more particularly described in said deed as certified by the Property Director be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named 61st STREET.

That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Department for recording and further disposition.
