

# RESOLUTION No. 200956

Adopted on OCT 6 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of PAUL P. PICKERING and DOROTHY B. PICKERING, husband and wife as to an undivided one-half interest, and SAN DIEGO TRUST AND SAVINGS BANK, as Trustee under their Trust No. 1075, as to a one-half interest, executed in favor of The City of San Diego, bearing date September 4, 1970, conveying to said City an easement and right-of-way for sewer purposes, through, along and across a portion of the Southwest Quarter of Section 6, Township 15 South, Range 2 West, San Bernardino Meridian, according to Official Plat thereof, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director be, and the same is hereby approved.

That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Department for recording and further disposition.
