

RESOLUTION No. 200975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of Consolidated Equipment Sales, Inc. is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of ONE TRACTOR-SCRAPER AND ONE HEAVY TRACTOR-BULLDOZER as follows:

ITEM NO. 1 - One (1) each Tractor-Scraper at a cost of \$56,465.00; terms net 30 days, plus sales tax, less a trade-in allowance of \$13,000.00 for a 1964 LeTorneau-Westinghouse Tractor-Scraper; and

ITEM NO. 2 - One (1) Heavy Tractor-Bulldozer at a cost of \$67,425.00; terms net 30 days, plus sales tax, less a trade-in allowance of \$16,900.00 for a 1965 International Tractor-Bulldozer.
