NOTHOMB, Licensed Land Surveyor, and entitled, "PACIFICA HILLS UNIT NO. 5 Being a subdivision of a portion of the Northwest Quarter of the Northwest Quarter of Section 26, Township 18 South, Range 2 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to United States Government Survey approved February 25, 1870.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets, to wit: Orchid Way and Reef Drive, for public purposes, and said streets are hereby declared to be public streets and dedicated to the public use.
