

RESOLUTION NO. 200989 OCT 13 1970

APPROVING MAP OF SEVEN OAKS UNIT NO. 19 SUBDIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC THE PUBLIC STREETS AND PORTIONS OF PUBLIC STREETS DEDICATED ON SAID MAP AND ACCEPTING ON BEHALF OF THE CITY OF SAN DIEGO CERTAIN ABUTTERS' RIGHTS OF ACCESS AS GRANTED ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, Registered Civil Engineer, and entitled, "SEVEN OAKS UNIT NO. 19 Being a subdivision of Rancho San Bernardo according to Map recorded August 21, 1883 in Book 2, Pages 462 through 469 of Patents, a portion of Seven Oaks Unit No. 6, Map No. 5325, and a portion of Seven Oaks Unit No. 11, Map No. 6065, all as filed in the office of the County Recorder of San Diego County; together with those portions of Pomerado Road, Lomica Drive, and Mantilla Road as vacated, all being in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets and portions of public streets, to wit: Bendito Drive, Relindo Drive, Higa Place, Opimo Drive, Ocaso Drive, Palero Road, Horado Road, Opimo Court, Relindo Court, Lomica Drive, Mantilla Road, portion of Rodada Drive, and portion of Rios Road for public purposes and said streets and portions of streets are hereby declared to be public streets and portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Pomerado Road and a portion

of Rios Road, adjacent and contiguous to Lot 2147, all as granted and shown on said map.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portions of public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
