

RESOLUTION No. 201003

Adopted on OCT 13 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of SACRAMENTO SAVINGS AND LOAN, a corporation, executed in favor of The City of San Diego, bearing date July 20, 1970, conveying to said City an easement and right-of-way for street purposes through, over and across portions of Section 36, Township 14 South, Range 3 West, San Bernardino Base and Meridian, according to United States Government Survey thereof, as more particularly described in said deed, as certified by the Property Director be, and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named CAMINO RUIZ, and the land therein conveyed as Parcel 2 is hereby dedicated as and for a public street and the same is hereby named MIRA MESA BOULEVARD.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
