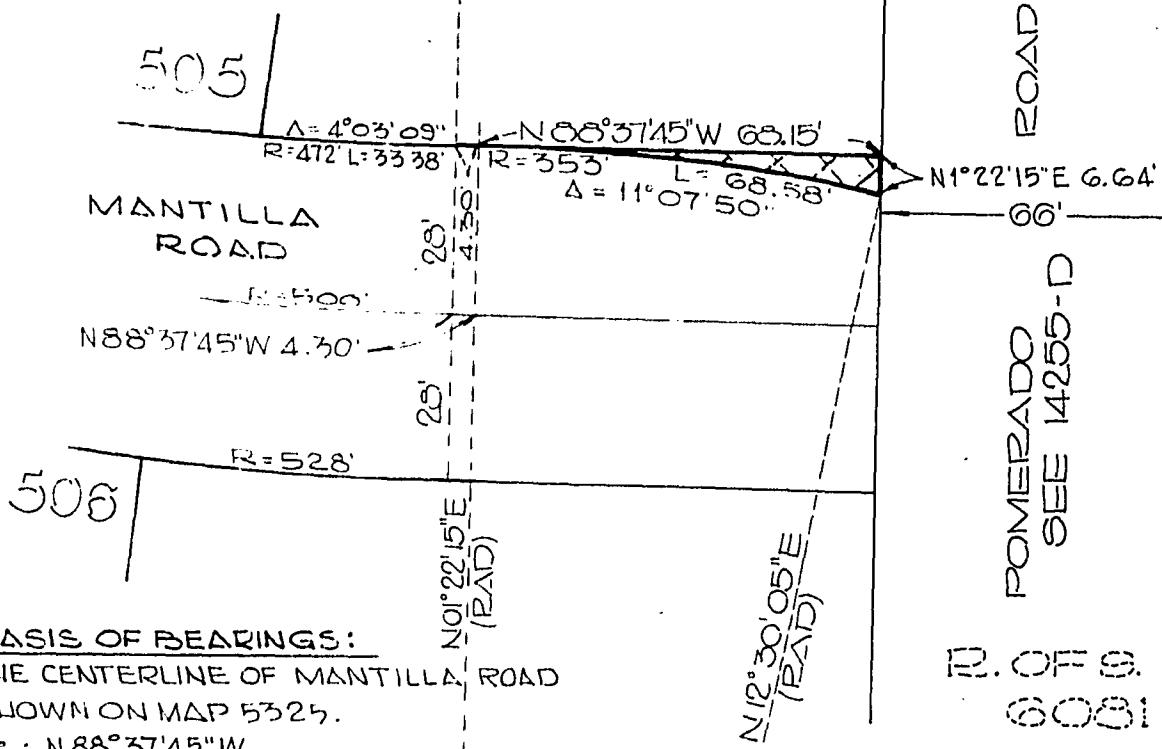

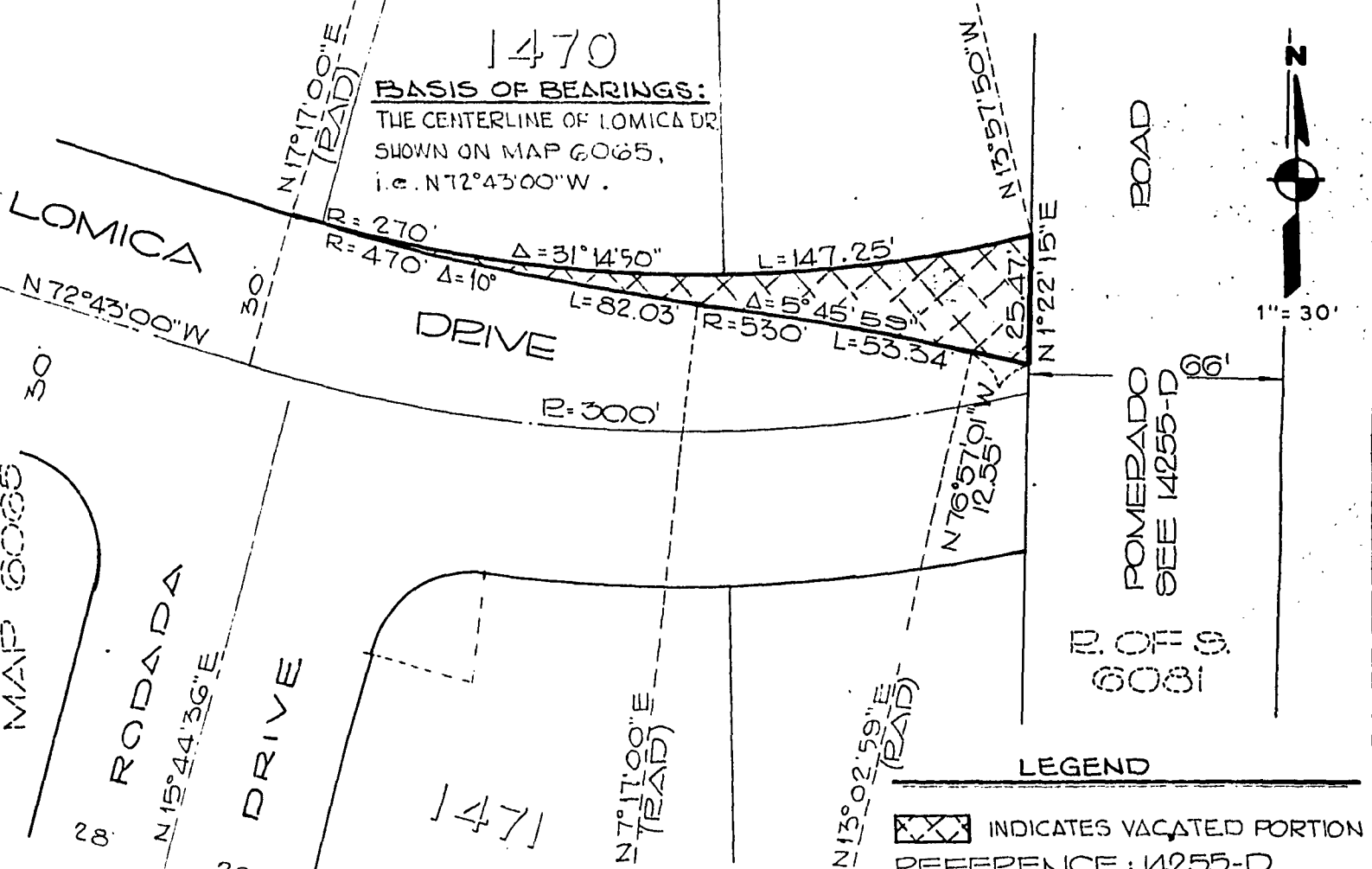
SEVEN OAKS UNIT NO. 6
