seal, to be recorded in the office of the County Recorder.

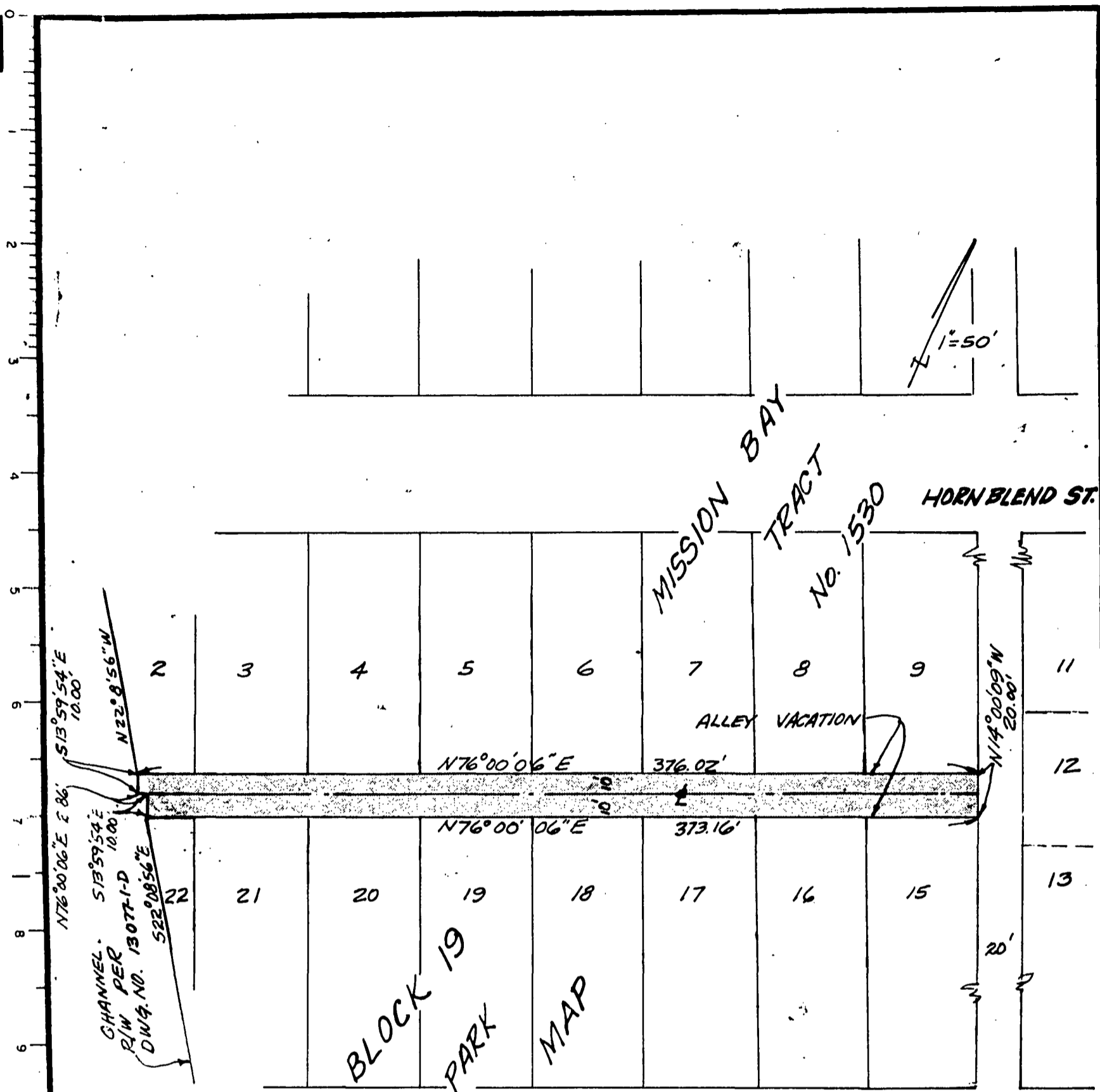
