

RESOLUTION NO. 201016 OCT 15 1970

APPROVING MAP OF VILLA LA JOLLA APARTMENTS UNIT NO. 1 SUBDIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC THE PUBLIC STREETS AND PORTION OF PUBLIC STREET DEDICATED ON SAID MAP, AND ACCEPTING ON BEHALF OF THE CITY OF SAN DIEGO, THE EASEMENTS AS GRANTED ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by GUY W. WINTON, JR., Registered Civil Engineer, and entitled, "VILLA LA JOLLA APARTMENTS UNIT NO. 1 Being a subdivision of portions of Pueblo Lots 1295 and 1299 and 1300 of The Pueblo Lands of San Diego, according to map thereof made by James Pascoe in 1870, a copy of which was filed in the Office of County Recorder of San Diego County, and is known as Miscellaneous Map No. 36, and portions of Blocks 1 and 8 and of streets and alleys now vacated and closed to public use, adjoining said Block 1, and of Aldrich Street and Cameron Street and alley in said Block 8, in Leavitt's Addition, according to Map thereof No. 117, filed in the Office of County Recorder of San Diego County, April 4, 1885.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets and portion of public street, to wit: Villa La Jolla Drive, Via Mallorca, Via Alicante and a portion of Gilman Drive, for public purposes, and said streets and portion of street are hereby declared to be public streets and portion of public street and dedicated to the public use.

MICROFILMED

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of THE CITY OF SAN DIEGO, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities; and further accepts on behalf of The City of San Diego, a municipal corporation, the open space easement granted on said map, subject to all the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portion of public street are accepted on behalf of the public as heretofore stated; and that those certain easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities; and the open space easement, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
