

RESOLUTION NO. 201021

OCT 15 1970

WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by city council resolution where those portions to be vacated have been superseded by relocation; and

WHEREAS, those portions of CAMERON STREET, between Aldrich Street and a point approximately 185 feet southerly of Aldrich Street; ALDRICH STREET, between Cameron Street and Gilman Drive; and the ALLEY in Block 8, Leavitt's Addition, adjacent to Lots 1 through 5, have been relocated by the approval on this date of the dedication of VIA ALICANTE by the acceptance of the final map of the subdivision to be known as Villa La Jolla Apartments Unit No. 1; and

WHEREAS, those properties adjoining those portions of CAMERON STREET, ALDRICH STREET and the ALLEY in Block 8, Leavitt's Addition, to be vacated will continue to have access or will be accessible by the street which has been dedicated with the approval on this date of the subdivision to be known as Villa La Jolla Apartments Unit No. 1; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That CAMERON STREET, between Aldrich Street and a point approximately 185 feet southerly of Aldrich Street; ALDRICH STREET, between Cameron Street and Gilman Drive; and the ALLEY in Block 8, Leavitt's Addition, adjacent to Lots 1 through 5, as more particularly shown on Drawing No. 12358-B on file in the office of the City Clerk as Document No.


733706 which said drawing is attached hereto marked Exhibit A and made a part hereof be, and the same is hereby ordered vacated.

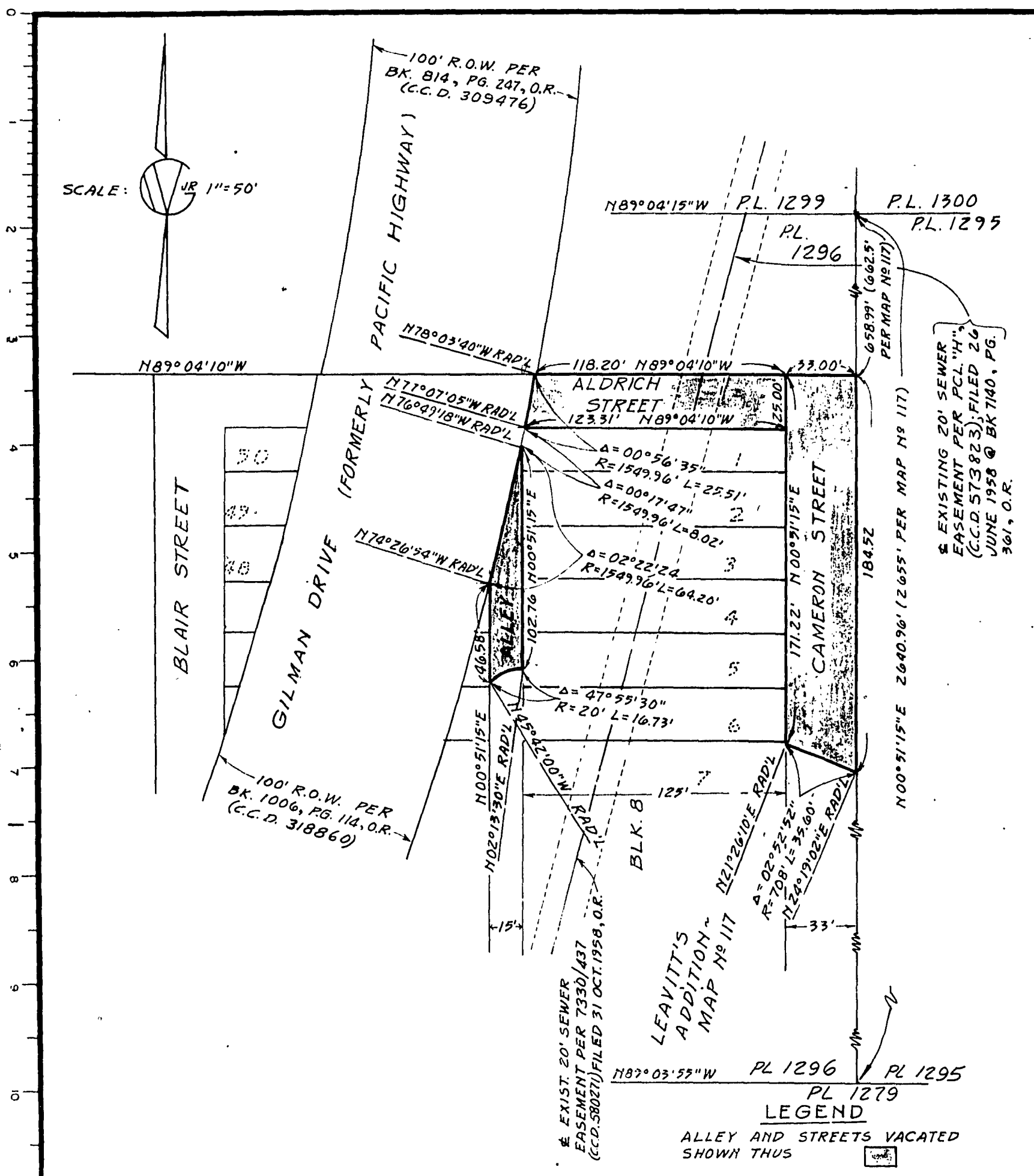
