

RESOLUTION No. 201027

Adopted on OCT 15 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the Offer to Dedicate of WILLIAMSON PARK CO., a California corporation, executed in favor of The City of San Diego, bearing date September 30, 1970, granting to said City an offer to dedicate to public use for future street purposes described as a portion of Lot 18, Rancho Mission of San Diego, in the City of San Diego, State of California, according to Partition Map on file in the Office of the County Clerk of San Diego County in Action No. 348 in Superior Court of said County entitled "Juan M. Luco, et al vs. The Commercial Bank of San Diego, et al," be, and the same is hereby accepted on the conditions therein expressed.

BE IT FURTHER RESOLVED, that by this acceptance the City does not dedicate to public use for street purposes the portion of land described in said instrument, but reserves the right to so dedicate at a future time.

BE IT FURTHER RESOLVED, that the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Council, the foregoing said offer to dedicate to the Property Department for recording and further disposition.
