

RESOLUTION No. 201030

That the acceptance by the City Manager of that deed of CITY HEIGHTS IMPROVEMENT COMMITTEE, INC., a California corporation, executed in favor of The City of San Diego, bearing date July 27, 1970, conveying to said City Lots 15, 16, 17 and 18 in Block 138 of City Heights, according to Map thereof No. 1007, filed in the Office of the County Recorder of San Diego County, October 3, 1906, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director be, and the same is hereby approved.

That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Department for recording and further disposition.
