

RESOLUTION NO. 201052 OCT 20 1970

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That the land conveyed to The City of San Diego for the
purpose of a public street and incidents thereto, through,
over, under, along and across the hereinafter described prop-
erty be, and the same is hereby set aside and dedicated as and
for a public street and the same is hereby named LANDIS STREET:

All that portion of Lot 24 and the South 2.00
feet of Lot 23, excepting the Easterly 72.50
feet of said Lots in Block 187 of City Heights,
in the City of San Diego, County of San Diego,
State of California, according to Map thereof
No. 1007, filed in the Office of the County
Recorder of San Diego County, October 3, 1906,
lying Southwesterly of a line described as
follows:

Beginning at a point on the Southwesterly line
of Lot 22 of said Block 187, distant thereon
South 15° 42' 11" East, 0.64 feet from the
Northwest corner of said Lot 22; thence South
45° 51' 19" East, 22.79 feet to a tangent
130.00 foot radius curve, concave Northeasterly;
thence Southeasterly along said curve through
an angle of 33° 24' 01", a distance of 75.78
feet; thence South 15° 42' 11" East, 3.58 feet
to the Southerly line of said Lot 24.

BE IT FURTHER RESOLVED, that the City Clerk of said City is
hereby authorized and directed to transmit a certified copy of
this resolution to the Property Department for recording and
further disposition.
