

RESOLUTION NO. 201060 OCT 20 1970

APPROVING MAP OF BERNARDO CENTER UNIT NO. 4  
SUBDIVISION AND ACCEPTING ON BEHALF OF THE  
PUBLIC THE PORTION OF A PUBLIC STREET DEDICATED  
ON SAID MAP, AND ACCEPTING ON BEHALF OF THE CITY  
OF SAN DIEGO THE EASEMENT GRANTED ON THIS MAP  
WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San  
Diego, as follows:

Said Council hereby finds that that certain map surveyed  
by WILLIAM B. RICK, Registered Civil Engineer, and entitled,  
"BERNARDO CENTER UNIT NO. 4 Being a subdivision of a  
portion of Rancho San Bernardo, in the City of San Diego,  
County of San Diego, State of California, according to Map  
thereof, recorded August 21, 1883, in Book 2, Page 462 of  
Patents.", is made in the manner and form prescribed by law  
and conforms to the surrounding surveys; that said map and  
the subdivision of land shown thereon is hereby approved and  
accepted; and said Council hereby accepts on behalf of the  
public, portion of a public street, to wit: a portion of  
Bernardo Center Drive for public purposes and said portion  
of a street is hereby declared to be a portion of a public  
street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts  
on behalf of The City of San Diego, a municipal corporation,  
the easement with the right of ingress and egress for the  
construction and maintenance of drainage facilities as granted  
and shown on said map, and subject to the conditions set forth  
thereon.

The Clerk of said City is hereby authorized and directed  
to endorse upon said map, as and for the act of the Council,  
that said Council has approved said subdivision map and that

said portion of a public street is accepted on behalf of the public as heretofore stated; and that the easement with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on this map within this subdivision, is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
