

RESOLUTION NO. 201072 OCT 22 1970

APPROVING MAP OF MIRA MESA VERDE UNIT NO. 15
SUBDIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC
THE PUBLIC STREETS AND PORTION OF PUBLIC STREET
DEDICATED ON SAID MAP, AND ACCEPTING ON BEHALF
OF THE CITY OF SAN DIEGO THE ABUTTERS' RIGHTS
OF ACCESS, TOGETHER WITH THE EASEMENTS AS GRANTED
ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San
Diego, as follows:

Said Council hereby finds that that certain map surveyed
by WILLIAM J. CLARKE, Licensed Land Surveyor, and entitled,
MIRA MESA VERDE UNIT NO. 15 Being a subdivision of a
portion of the Northeast Quarter of the Northeast Quarter of
Section 35 and a portion of the Northwest Quarter of Section
36 all in Township 14 South, Range 3 West, San Bernardino
Meridian, in the City of San Diego, County of San Diego, State
of California, according to official Plat thereof.", is made
in the manner and form prescribed by law and conforms to the
surrounding surveys; that said map and the subdivision of
land shown thereon is hereby approved and accepted; and said
Council hereby accepts on behalf of the public, the public
streets and portion of public street, to wit: Montongo
Street, Montongo Circle, Westmore Road, Westmore Lane, West-
more Court, Westmore Circle, Westmore Place, Reagan Road,
Avenida Del Gato, Deering Street, Valdosta Avenue, Peach
Point Avenue and a portion of Worthing Avenue, for public
purposes; and said streets and portion of street are hereby
declared to be public streets and portion of public street
and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council accepts on
behalf of The City of San Diego, a municipal corporation,

any and all abutters' rights of access in and to Montongo Street adjacent and contiguous to Lots 2071, 2072, 2073, 2074, 2208 and 2209; any and all abutters' rights of access in and to Montongo Circle adjacent and contiguous to Lot 2202; any and all abutters' rights of access in and to Westmore Road, adjacent and contiguous to Lots 2000, 2021, 2022, 2198, 2148, 2147, 2130, 2129, 2232, 2231, 2223, and 2222; any and all abutters' rights of access in and to Westmore Lane adjacent and contiguous to Lot 2213; any and all abutters' rights of access in and to Westmore Place adjacent and contiguous to Lot 2182; any and all abutters' rights of access in and to Reagan Road adjacent and contiguous to Lots 2054, 2055, 2118, 2091 and 2090; any and all abutters' rights of access in and to Avenida Del Gato adjacent and contiguous to Lots 2179, 2045 and 2046; any and all abutters' rights of access in and to Valdosta Avenue adjacent and contiguous to Lots 2010, 2011, 2032, 2170, 2158, 2119 and 2105, all as granted and shown on said map.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of drainage and sewer facilities as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council that said Council has approved said subdivision map and that said public streets and portion of public street are accepted on behalf of the public as heretofore stated; and that those

certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of drainage and sewer facilities as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
