Craig W. Christie	PARK AND PUBLIC BUILDINGS DEPT. Buildings & Facilities Division	\$40	Suggestion was to provide reflectors behind lights for the paint spray booth; also to provide covers to keep dust and paint spray from light bulbs. This improved lighting is expected to save about \$400 a year spent to redo poor painting because of poor light and in cleaning lights.
Robert H. Cord	FIRE DEPARTMENT	\$35	Arrangement has been made, as the result of this suggestion, to obtain gas for engine at station #35 at a lower cost and much nearer location. A \$351 per year saving in the cost of gasoline is estimated.
George R. Ikeda	PARK AND PUBLIC BUILDINGS DEPT. Buildings & Facilities Division	\$15	Suggester redesigned a section of a lifeguard tower that had to be replaced so that the cost of replacement was \$160 less than the original design would have cost.
Shirley L. Haber	WATER UTILITIES DEPARTMENT	\$15	The use of a card form instead of a letter of acknowledgement serves the purpose well and requires less time and effort. \$144 a year saving in clerical time is estimated.
