

RESOLUTION NO. 201077 OCT 22 1970

RESOLUTION OF THE COUNCIL OF THE CITY
OF SAN DIEGO, CALIFORNIA, APPROVING
OFFICIAL STATEMENT IN CONNECTION WITH
THE SALE OF \$9,500,000 BONDS ON BEHALF
OF CITY OF SAN DIEGO PENASQUITOS SEWER
DISTRICT.

WHEREAS, resolutions providing for the issuance
and sale of \$9,500,000 Bonds on behalf of the City of
San Diego Penasquitos Sewer District have been adopted;
and

WHEREAS, it is desirable that information con-
cerning such City and such bonds be furnished to prospective
bidders;

NOW, THEREFORE, the Council of the City of San
Diego DOES HEREBY RESOLVE, DETERMINE AND ORDER as follows:

Section 1. A draft of the Official Statement
to be furnished to prospective bidders for the City of San
Diego Penasquitos Sewer District, 1970 Sewer Bonds, Series
A, and to the successful bidder therefor, has been presented
to this Council. Such draft is hereby approved and the City
Clerk is hereby directed to file said draft in his office,
and to identify it as being the Official Statement so
approved by this Resolution, by an endorsement thereon to
that effect, over his signature.

Section 2. Prior to final printing, the City Clerk shall make such changes as are necessary to conform the Official Statement to Resolutions Nos. 201037 and 201038, and such other changes as are necessary or desirable to correct errors or clarify the meaning of parts thereof.

Section 3. The City Clerk is hereby authorized and directed to cause to be furnished to prospective bidders, upon request therefor, a reasonable number of copies of the notice inviting bids and a reasonable number of copies of said Official Statement substantially in the form hereinabove approved.
