

RESOLUTION NO. 201081 OCT 22 1970

WHEREAS, CHARLES F. BALDWIN applied to the City Council for special permission to waive underground electrical utility and telephone line requirements in connection with the subdivision map of GAESTELLE SUBDIVISION, a one-lot subdivision of Lots 17 and 18 and the westerly ten feet of Lot 19, Grantville and Outlots; and
