

RESOLUTION NO. 201082 OCT 21 1970

WHEREAS, the Planning Commission of The City of San Diego has held a public hearing to consider the proposed "PARK NORTH-EAST COMMUNITY PLAN," prepared by the Planning Department in cooperation with the Park North-East Association and interested citizens of this area of the City; and

WHEREAS, the "PARK NORTH-EAST COMMUNITY PLAN" is a refinement of the adopted "MID-CITY DEVELOPMENT PLAN," incorporates the adopted North Park Commercial Area Plan, and primarily addresses itself to the preservation of older but well maintained single family areas while providing guidance to newer apartment developments for that area generally bounded on the north by Mission Valley, on the east by Interstate 805 and State Highway 15, on the south by "A" Street and on the west by Balboa Park and Park Boulevard; and

WHEREAS, on September 23, 1970, the Planning Commission adopted and recommended for approval to the City Council the "PARK NORTH-EAST COMMUNITY PLAN"; and

WHEREAS, the Council of The City of San Diego has held a public hearing to consider this plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:
