

RESOLUTION NO. 201092 OCT 27 1970

APPROVING MAP OF GOLDEN VALLEY UNIT NO. 1
SUBDIVISION AND ACCEPTING ON BEHALF OF THE
CITY OF SAN DIEGO THE EASEMENT GRANTED ON
THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, Registered Civil Engineer, and entitled, "GOLDEN VALLEY UNIT NO. 1 Being a subdivision of a portion of Lot 5 of the Partition of Pueblo Lot 1105, in the City of San Diego, County of San Diego, State of California, according to Referee's Map thereof made in that certain Action entitled 'Thomas J. Daley vs. Arpad Haraszthy, et al', being Numbered 1029 in the Superior Court of California in and for the County of San Diego, which said Map is filed in the office of the County Clerk of said San Diego County, and portions of Lots 9 through 12, and 13 of E. W. Morse's subdivision of the West Half of Pueblo Lot 1106, according to Map thereof No. 103, filed in the office of County Recorder of San Diego County, November 6, 1885.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on said map and subject to the conditions set forth thereon.
