

RESOLUTION NO. 201094 OCT 27 1970

APPROVING MAP OF LA JOLLA ALTA UNIT NO. 1 SUB-DIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC THE PUBLIC STREETS DEDICATED ON SAID MAP, AND ACCEPTING ON BEHALF OF THE CITY OF SAN DIEGO THE ABUTTERS' RIGHTS OF ACCESS TOGETHER WITH THE EASEMENTS AS GRANTED ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by W. R. NOTHOMB, Licensed Land Surveyor, and entitled, "LA JOLLA ALTA UNIT NO. 1 Being a subdivision of portions of Pueblo Lots 1780 and 1781 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, a copy of which said Map was filed in the office of the County Recorder of San Diego County and is known as Miscellaneous Map No. 36.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the public streets, to wit: Calle Alta, Westknoll Lane, Westknoll Drive, Castle Hills Drive, Calle Vaquero, Calle Miramar and Calle Camille, for public purposes and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Calle Vaquero, adjacent and contiguous to Lots 40, 42, 43, 44, and 45 and any and all abutters' rights of access in and to Calle Alta, adjacent and contiguous to Lots 55, 56, 57, 58, 59, 60, 61, 62, 63 and 64 and any and all abutters' rights of access in and to Castle Hills Drive adjacent and contiguous to Lot 9, all as granted and shown on said map.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of water and drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access together with the easements with the right of ingress and egress for the construction and maintenance of water and drainage facilities as granted and shown on this map within this subdivision are accepted on
