

RESOLUTION NO. 201098 OCT 27 1970

APPROVING MAP OF VISTA CAMINO DEL RIO UNIT NO. 1
SUBDIVISION AND REJECTING THE OFFER OF DEDICATION
FOR PUBLIC USE THAT PORTION MARKED "RESERVED FOR
FUTURE STREET" AS SHOWN ON THIS MAP WITHIN THIS
SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by WILLIAM B. RICK, Registered Civil Engineer, and entitled,
"VISTA CAMINO DEL RIO UNIT NO. 1 Being a subdivision of
a portion of Pueblo Lot 1110 of the Pueblo Lands of San Diego,
in the City of San Diego, County of San Diego, State of
California, according to Map thereof made by James Pascoe
in 1870, a copy of which said Map was filed in the office
of the County Recorder of San Diego County November 14, 1921,
and is known as Miscellaneous Map No. 36.", is made in the
manner and form prescribed by law and conforms to the surround-
ing surveys; that said map and the subdivision of land shown
thereon is hereby approved and accepted; and said Council
rejects as a dedication for public street that portion of
Lot 1 marked "Reserved for Future Street" as shown on this
map within this subdivision under the provisions of
Section 11616 of the Business and Professions Code.

The Clerk of said City is hereby authorized and directed
to endorse upon said map, as and for the act of the Council,
