

RESOLUTION NO. 201102 OCT 27 1970

APPROVING MAP OF WESTWOOD UNIT NO. 7 SUBDIVISION
AND ACCEPTING ON BEHALF OF THE PUBLIC THE PUBLIC
STREETS AND PORTION OF PUBLIC STREET DEDICATED
ON SAID MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by LEO H. BARBOUR, Registered Civil Engineer, and entitled,
"WESTWOOD UNIT NO. 7 Being a subdivision of a portion of
Rancho San Bernardo, in the City of San Diego, County of
San Diego, State of California, according to Map thereof filed
in the office of the County Recorder of San Diego County, in
Book 2, Page 462 of Patents.", is made in the manner and form
prescribed by law and conforms to the surrounding surveys;
that said map and the subdivision of land shown thereon is
hereby approved and accepted; and said Council hereby accepts
on behalf of the public the public streets and portion of
public street, to wit: Matinal Drive, Cabela Drive, Luz
Road, Cabela Place, Luz Place and a portion of Matinal Road
for public purposes, and said streets and portion of street
are hereby declared to be public streets and portion of public
street and dedicated to the public use.

The Clerk of said City is hereby authorized and directed
to endorse upon said map, as and for the act of the Council,
that said Council has approved said subdivision map and that
