BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the bid of Eastern Industrial Leasing Corporation is hereby accepted, and the City Manager is hereby authorized to execute a contract for the LEASE OF LABORATORY EQUIPMENT as may be required for the period of one year beginning November 1, 1970 through October 31, 1971 at a monthly rate of \$197.35, plus sales tax, and an initial deposit of \$717.50 and estimated freight charge of \$75.00; with option to renew agreement on a year-to-year basis for three (3) additional years, with option to purchase equipment or continue lease after fourth year.
