

RESOLUTION NO. 201.126 OCT 29 1970

WHEREAS, The City of San Diego desires to undertake a Municipal Command and Control System Project to be funded in part from funds in the amount of \$150,000, made available by a Discretionary Grant from the Federal Law Enforcement Assistance Administration through the Federal Omnibus Crime Control and Safe Streets Act of 1968, administered by the California Council on Criminal Justice; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a contract with the California Council on Criminal Justice for acceptance of a Discretionary Grant from the Federal Law Enforcement Assistance Administration, under the terms and conditions set forth in the contract on file in the office of the City Clerk as Document No. 733848

BE IT FURTHER RESOLVED, that The City of San Diego agrees to provide the required matching funds in the amount of \$100,000 to said project, such sum to be allocated out of Capital Outlay Fund No. 245.

BE IT FURTHER RESOLVED, that grant funds received hereunder shall be used to supplement and not supplant ongoing law enforcement expenditures, and that matching funds will be used in that manner specified within the Federal Grant.
