

RESOLUTION NO. 201130 OCT 29 1970

WHEREAS, The City of San Diego has undertaken the construction of the Casa del Prado in Balboa Park; and

WHEREAS, the Committee of 100 has requested that the interior design of the second floor loggia be revised and that the original exterior ornamentation for the exterior facade of the second floor loggia be reproduced on the new building; and

WHEREAS, the Committee of 100 has generously offered to contribute at this time to The City of San Diego the sum of \$50,000 toward the cost of this additional work and has pledged a further contribution after January 1, 1971 for the same purpose; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That The City of San Diego hereby accepts the generous contribution of \$50,000 from the Committee of 100 and directs that said contribution be deposited in Trust Fund 302 to be used solely and exclusively for the requested changes in construction of the second floor loggia of the Casa del Prado in Balboa Park.

2. That all future contributions for this purpose from the Committee of 100 be similarly accepted and deposited.
