

RESOLUTION NO. 201137 OCT 29 1970

WHEREAS, The City of San Diego is the owner of a portion of Tract 6, Rancho El Cajon; and

WHEREAS, the County of San Diego, a body politic and corporate, has requested the conveyance of an easement for road purposes across said property required by the County for the realignment of Bradley Street to alleviate traffic congestion in and around Gillespie Field; and

WHEREAS, the purposes for which the easement is required are public purposes; and

WHEREAS, Section 22.0907 of the San Diego Municipal Code authorizes the conveyance of City property to public agencies for public purposes without complying with the provisions relating to the advertising for bids and auction sales contained in the Municipal Code; and

WHEREAS, the City Manager, pursuant to Section 22.0907 of the San Diego Municipal Code, has recommended that said easement be conveyed to the County of San Diego, a body politic and corporate; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That, in consideration of the benefits to accrue to the people of said City, the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a deed conveying to the COUNTY OF SAN DIEGO, a body politic and corporate, an easement for road purposes across said portion of Tract 6, Rancho El Cajon, as more particularly described in the form of Deed of Easement, on file in the office of the City Clerk as Document No. 733847.
