

RESOLUTION NO. 201148 NOV 3 1970

APPROVING MAP OF BASSETT SUBDIVISION AND ACCEPTING
ON BEHALF OF THE CITY OF SAN DIEGO THE EASEMENT
GRANTED ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by DON NASLAND, Licensed Land Surveyor, and entitled, "BASSETT
SUBDIVISION Being a subdivision of portions of Lots 1 to 8
inclusive, and 31 to 38 inclusive, in Block 193 of City Heights,
in the City of San Diego, County of San Diego, State of Califor-
nia, according to Map thereof No. 1007, filed in the office of
the County Recorder of San Diego County, October 3, 1906, to-
gether with a portion of the alley in said Block 193 vacated
and closed.", is made in the manner and form prescribed by
law and conforms to the surrounding surveys; that said map
and the subdivision of land shown thereon is hereby approved
and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts
on behalf of The City of San Diego, a municipal corporation,
the easement with the right of ingress and egress for the
construction and maintenance of sewer facilities as granted
and shown on said map and subject to the conditions set forth
thereon.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
