BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute for and on behalf of City, Utilities Agreement No. 15109-C with the STATE DIVISION OF HIGHWAYS for rearrangement of water facilities on State Road 11-SD-805, 18.3-21.0 between 0.2 mile north of Friars Road and 0.4 mile north of Route 395 to accommodate freeway construction, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 733906.

BE IT FURTHER RESOLVED, that Resolution No. 197271, adopted June 24, 1969, and Resolution No. 197699, adopted October 12, 1969, be, and they are hereby rescinded.
