

RESOLUTION No. 201167

Adopted on NOV 3 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the petition for the construction of certain improvements on the north side of GENEVA STREET, between Winston Street and Beverly Street, under the provisions of the Improvement Act of 1911, consisting of two sheets and filed under Document No. 733916, is hereby granted.

That the City Engineer be, and he is hereby directed to prepare plans, drawings, typical cross-sections, profiles and specifications for the installation of sidewalk on the north side of GENEVA STREET, between Winston Street and Beverly Street, in the City of San Diego, together with estimates of the costs and expenses of such work and to furnish this Council with a description of the district and a plat showing the exterior boundaries of the district to be included in the assessment for the work and improvement hereinabove mentioned.
