

RESOLUTION No. 201172

Adopted on NOV 3 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of MARK N. BALDWIN and HARRIET B. BALDWIN, husband and wife, as joint tenants, as to an undivided one-half interest and JOHN H. CHALMERS and JANE B. CHALMERS, husband and wife, as joint tenants, as to an undivided one-half interest, executed in favor of The City of San Diego, bearing date October 28, 1970, conveying to said City an easement and right-of-way for street purposes through, over and across portions of Lot 32 of Aloha Tract, according to Map thereof No. 611, filed in the Office of the County Recorder of San Diego County, August 8, 1889, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director be, and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named CORONADO AVENUE, and the land therein conveyed as Parcel 2 is hereby dedicated as and for a public street and the same is hereby named 19TH STREET.

That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Department for recording and further disposition.
