

RESOLUTION NO. 201177 NOV 3 1970

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, APPROVING PLANS AND PROFILES SHOWING THE CONTEMPLATED CHANGES AND MODIFICATIONS IN THE WORK DESCRIBED IN RESOLUTION OF INTENTION NO. 200676 FOR THE IMPROVEMENT OF CORONADO AVENUE.

WHEREAS, this City Council did on September 1, 1970 adopt Resolution of Intention No. 200676 and declare its intention to order the construction of certain improvements as more fully described therein and on the plans, profiles and drawings therein referred to, and did provide for the cost of certain work to be assessed against the district described in said Resolution of Intention; and

WHEREAS, the public interest, convenience and necessity require that (1) certain changes and modifications be made in the proposed work to be done in said Resolution of Intention, and (2) that said Resolution of Intention be amended by the additional requirement of increasing the number of necessary sewer laterals from three to four, an increase of one; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the plans, drawings, typical cross-sections, profiles and specifications for the improvement of CORONADO AVENUE, heretofore filed in the office of the City Clerk as Document No. 733154 and approved by Resolution No. 200675 be, and the same are amended to conform with City of San Diego Engineering Department Drawing Nos. 13262-1-D through 13262-9-D, filed in the office of the City Clerk as Document No. 733499, and the same are hereby approved and adopted as the official drawings, typical cross-sections, profiles and specifications for said work and improvement.
