

RESOLUTION NO. 201190 NOV 5 1970

APPROVING MAP OF FAIRWAY PARK UNIT NO. 1 SUBDIVISION
AND ACCEPTING ON BEHALF OF THE PUBLIC THE PUBLIC
STREETS DEDICATED ON SAID MAP, AND ACCEPTING ON BEHALF
OF THE CITY OF SAN DIEGO, THE EASEMENTS GRANTED ON
THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by DON NASLAND, Licensed Land Surveyor, and entitled, "FAIR-
WAY PARK UNIT NO. 1 Being a subdivision of portions of
Pueblo Lots 1206 and 1211, in the City of San Diego, in the
County of San Diego, State of California, according to Map
of the Pueblo Lands of San Diego, made by Charles H. Poole
in 1856, as described in Deed to Conner, recorded in Book 5,
Page 191 of Deeds, Records of San Diego County.", is made
in the manner and form prescribed by law and conforms to the
surrounding surveys; that said map and the subdivision of land
shown thereon is hereby approved and accepted; and said Council
hereby accepts on behalf of the public, the public streets, to
wit: Mt. Ariane Drive, Mt. Ariane Court, Mt. Ariane Terrace,
Mt. Burnham Drive and Mt. Burnham Place, for public purposes,
and said streets are hereby declared to be public streets and
dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts
on behalf of The City of San Diego, a municipal corporation,
the easements with the right of ingress and egress for the
construction and maintenance of drainage facilities, as granted
and shown on said map, and subject to the conditions as set
forth thereon.

The Clerk of said City is hereby authorized and directed
to endorse upon said map, as and for the act of the Council,

that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that those certain easements with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
