

RESOLUTION NO. 201193 NOV 5 1970

WHEREAS, Wanda Brocchini is the owner of certain real property and improvements located at 6839 Jamacha Road, San Diego, California, and more particularly described as follows:

West 40' of North 60' of Lot 3, Block B,
Resubdivision of Blocks A and B, Encanto

WHEREAS, said real property has been improved with a certain building situate thereon; and

WHEREAS, said building has been found by the Building Inspection Director to be substandard and has been found to constitute a hazard to public safety, health and welfare by reason of inadequate maintenance, dilapidation and fire hazard; and

WHEREAS, the owner of the above-described property was notified by letter from the Building Inspection Director, dated March 11, 1970, of these findings; and

WHEREAS, on August 26, 1970, at a public hearing, the Housing Advisory and Appeals Board approved said findings;

as follows:

1. The building situate on the property described above is declared to be a public nuisance.

2. The City Attorney is authorized and instructed to take appropriate legal action to abate the aforesaid nuisance.
