

RESOLUTION NO. 201199 NOV 5 1970

WHEREAS, Resolution No. 199253, adopted March 12, 1970, authorized the Mayor and City Clerk to execute, for and on behalf of the City, a deed conveying to the City of La Mesa, a municipal corporation, portions of Lots 1, 2 and 3, Clement's Acres and portions of Lots 1, 2, 3, 4 and 5, Gertrude Munro Tract, in the City of La Mesa, County of San Diego, State of California, all as more particularly described in said deed, a copy of which is on file in the office of the City Clerk as Document No. 731210; and

WHEREAS, said deed authorized the conveyance of an easement of a portion of the property required by said City of La Mesa; and

WHEREAS, a new deed has been prepared conveying in fee the entire right of way requirements to said City of La Mesa; and

WHEREAS, said Resolution No. 199253 should be rescinded and said deed cancelled; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:
