

RESOLUTION NO. 201201 NOV 5 1970

WHEREAS, the Planning Commission of The City of San Diego has held a public hearing to consider the proposed Mission-Pacific Beach Community Plan, prepared by the Planning and Community Development Departments in cooperation with the citizens of the Mission-Pacific Beach area of the City; and

WHEREAS, the Mission-Pacific Beach Community Plan will serve as a guide for the development of an area comprising approximately 4.5 square miles of land bounded on the north by the adopted La Jolla Community Plan boundary, on the east by Interstate 5, on the south by Mission Bay Park and on the west by the Pacific Ocean; and

WHEREAS, on September 23, 1970, the Planning Commission adopted and recommended for approval to the City Council the Mission-Pacific Beach Community Plan; and

WHEREAS, the Council of The City of San Diego has held a public hearing to consider this plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

This Council hereby adopts the MISSION-PACIFIC BEACH COMMUNITY PLAN, a copy of which is on file in the office of the City Clerk as Document No. 733920.
