

RESOLUTION No. 201218

Adopted on NOV 10 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the petition for the construction of certain improvements in the Linda Vista Chirp Area on HYATT, EAST HYATT, FULTON, WEST INGERSOLL, EAST INGERSOLL, NORTH JUDSON, RICHLAND STREETS and GATLING COURT, under the provisions of the Improvement Act of 1911, consisting of 15 sheets and filed under Document No. 733979, is hereby granted.

That the City Engineer be, and he is hereby directed to prepare plans, drawings, typical cross-sections, profiles and specifications for the installation of sidewalks on HYATT STREET, north and west sides between East Hyatt and Judson; EAST HYATT, north and east sides between Hyatt and Hyatt; FULTON STREET, south side between Hyatt and Judson; WEST INGERSOLL STREET, south and west sides between Hanford Drive and Fulton; EAST INGERSOLL STREET, east side between Hanford Drive and Fulton; NORTH JUDSON STREET, north and east sides between Hyatt and Fulton; RICHLAND STREET, both sides between North Judson and Genesee; and GATLING COURT, north side between East Hyatt and Flushing Court, in the City of San Diego, together with estimates of the costs and expenses of such work and to furnish this Council with a description of the district and a plat showing the exterior boundaries of the district to be included in the assessment for the work and improvement hereinabove mentioned.
