RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO, CALIFORNIA, AWARING \$9,500,000  
PENASQUITOS SEWER DISTRICT BONDS TO THE  
BEST RESPONSIBLE BIDDER, REJECTING ALL  
OTHER BIDS AND FIXING THE INTEREST RATES  
ON THE BONDS.

WHEREAS, at the time and place fixed for the opening  
of bids for the \$9,500,000 City of San Diego Penasquitos  
Sewer District, 1970 Sewer Bonds, Series A, numbered  
1 through 1900, all bids were publicly opened, examined and  
read, and a tabulation thereof has been entered in the  
Council's minutes; and

WHEREAS, the bid of the bidder named below is the best  
bid made by a responsible bidder for the bonds; NOW, THERE-  
FORE,

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

1. The bid of Bank of America N.T. & S.A. offering  
\$9,314,085, plus accrued interest to date of delivery, for  
\$9,500,000 City of San Diego Penasquitos Sewer District, 1970  
Sewer Bonds, Series A, to bear interest payable annually for  
the first year and semiannually thereafter at the following  
rates:

1973 to 1979	6.00%
1980 to 1983	6.75%
1984	6.90%
1985	7.00%
1986 to 1990	7.25%

is the bid for the bonds yielding the lowest net interest cost.

Such bid is hereby accepted and the bonds are awarded to such bidder in accordance with the terms of its proposal.

2. The bid other than the one accepted in paragraph 1 above is hereby rejected and the City Clerk is directed to return the bid check accompanying the rejected bid to the respective bidder.

3. The interest rates on the bonds are hereby fixed at the rates stated in paragraph 1 above.

4. The City Treasurer is hereby directed to deliver the bonds to the successful bidder upon the payment of \$9,314,085, plus accrued interest to date of delivery.
