

RESOLUTION NO. 201248 NOV 12 1970

WHEREAS, it appears to be in the public interest to change the name of a portion of KEARNY VILLA ROAD, from Cardinal Drive 800 feet southerly to its terminus, to CARDINAL LANE, and to name the new unnamed street between Cardinal Drive and Genesee Avenue as CARDINAL ROAD; and

WHEREAS, the Planning Commission of The City of San Diego has recommended approval of the renaming of a portion of KEARNY VILLA ROAD and the naming of the unnamed street CARDINAL ROAD; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That a portion of Kearny Villa Road, from Cardinal Drive 800 feet southerly to its terminus be, and the same is hereby renamed CARDINAL LANE.
2. That the new unnamed street between Cardinal Drive and Genesee Avenue be, and it is hereby named CARDINAL ROAD.
3. The City Clerk of said City is hereby directed to file a certified copy of this resolution in the office of the County Recorder and the County Surveyor of San Diego County.
