

RESOLUTION NO. 201258 NOV 17 1970

APPROVING MAP OF LA JOLLA SHORES HEIGHTS ANNEX  
SUBDIVISION AND ACCEPTING ON BEHALF OF THE CITY  
OF SAN DIEGO THE ABUTTERS' RIGHTS OF ACCESS AS  
GRANTED ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed  
by CHARLES W. CHRISTENSEN, Registered Civil Engineer, and  
entitled, "LA JOLLA SHORES HEIGHTS ANNEX Being a sub-  
division of a portion of Pueblo Lot 1296 of the Pueblo Lands  
of San Diego, in the City of San Diego, County of San Diego,  
State of California, according to Map thereof made by James  
Pascoe in 1870, a certified copy of said Map was filed in  
the office of County Recorder of San Diego County, November 14,  
1921 as Miscellaneous Map No. 36.", is made in the manner and  
form prescribed by law and conforms to the surrounding surveys;  
that said map and the subdivision of land shown thereon is  
hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council accepts on  
behalf of The City of San Diego, a municipal corporation, any  
and all abutters' rights of access in and to Torrey Pines  
Road, adjacent and contiguous to Lots 201 and 202, and any  
and all abutters' rights of access in and to Scenic Place,

adjacent and contiguous to Lots 203 through 205; all as granted and shown on said map.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that those certain abutters' rights of access as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
