

RESOLUTION NO. 201260 NOV 17 1970

APPROVING MAP OF CLAIREMONT MESA INDUSTRIAL PARK  
UNIT NO. 1 SUBDIVISION AND ACCEPTING ON BEHALF  
OF THE PUBLIC PORTIONS OF PUBLIC STREETS DEDICATED  
ON SAID MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed  
by DON NASLAND, Licensed Land Surveyor, and entitled, "CLAIRE-  
MONT MESA INDUSTRIAL PARK UNIT NO. 1 Being a subdivision  
of a portion of Lot 52, in the Highlands, in the City of San  
Diego, County of San Diego, State of California, according  
to Map thereof No. 284, filed in the office of the County  
Recorder of San Diego County, March 16, 1887.", is made in  
the manner and form prescribed by law and conforms to the  
surrounding surveys; that said map and the subdivision of  
land shown thereon is hereby approved and accepted; and  
said Council hereby accepts on behalf of the public, portions  
of public streets, to wit: portion of Ronson Road and portion  
of Engineer Road, for public purposes, and said portions of  
streets are hereby declared to be portions of public streets  
and dedicated to the public use.

The Clerk of said City is hereby authorized and directed  
to endorse upon said map, as and for the act of the Council,  
that said Council has approved said subdivision map and that
