

RESOLUTION NO. 201262 NOV 17 1970

APPROVING MAP OF FRIAR ESTATES SUBDIVISION AND
ACCEPTING ON BEHALF OF THE CITY OF SAN DIEGO
THE ABUTTERS' RIGHTS OF ACCESS TOGETHER WITH
THE EASEMENT AS GRANTED ON THIS MAP WITHIN THIS
SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by ROBERT E. YOUNG, Registered Civil Engineer, and entitled,
"FRIAR ESTATES Being a subdivision of a portion of that
unnumbered Pueblo Lot shown on the Map of the Pueblo Lands
of San Diego, made by James Pascoe, said Map known as
Miscellaneous Map No. 36, on file in the office of the County
Recorder of San Diego County, all in the City of San Diego,
County of San Diego, State of California.", is made in the
manner and form prescribed by law and conforms to the surround-
ing surveys; that said map and the subdivision of land shown
thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council accepts on
behalf of The City of San Diego, a municipal corporation, any
and all abutters' rights of access in and to Friars Road,
adjacent and contiguous to Lot 1, except at driveway locations,
as granted and shown on said map.

on behalf of The City of San Diego, a municipal corporation,

the easement with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council that said Council has approved said subdivision map and that those certain abutters' rights of access together with the easement with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on this map within this subdivision are accepted on behalf of the City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
