

RESOLUTION No. 201274

Adopted on NOV 17 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the petition for the construction of certain improvements on the ALLEY, BLOCK 243, SAN DIEGO LAND AND TOWN COMPANY'S ADDITION, under the provisions of the Improvement Act of 1911, consisting of two sheets and filed under Document No. 734028 is hereby granted.

That the City Engineer be, and he is hereby directed to prepare plans, drawings, typical cross-sections, profiles and specifications for grading and paving as an alley section the ALLEY, BLOCK 243, SAN DIEGO LAND AND TOWN COMPANY'S ADDITION, in the City of San Diego, together with estimates of the costs and expenses of such work and to furnish this Council with a description of the district and a plat showing the exterior boundaries of the district to be included in the assessment for the work and improvement hereinabove mentioned.
